<u>Police Departments</u> – Chief Sullivan reported that we have an officer that is at the Criminal Justice Academy in their 2nd week and is doing well. Also trying to make contact with a potential new officer, to set up communication that the Personal and Police Committee may speak with him.

<u>Personnel/Mechanics</u> - Per Council Lady Harney, we have an employee that return and has requested to return as a part time person. Per Mr. Youmans, we had one of our new police vehicles that was damaged with a faulty hood latch. Also wanting to change the police department decals from red to blue.

<u>Water and Sewer Department</u> - Alan Stanley, Water & Sewer Superintendent, and the employees have started on the reading of the meters for the month. In 3 weeks' time, they have fixed 20 leaks throughout the Town. We were given 60 days to fix and repair every leak in the Town of Allendale and we are ahead of schedule.

<u>Sanitation</u> – Lonzado Badger, Streets Superintendent states that they are still cutting grass throughout the Town. Continuing to pick up limbs and bags of leaves throughout the Town. Mr. Badger let the citizens know that Republic the trash company for the Town, should be back on track. Also, there is a problem with citizens dumping trash into the dumpsters throughout the Town.

<u>Community Development</u> – Council Lady Lewis, advised that the ARTS team went around to the businesses in the Town and took pictures with them. They provided the businesses with cards that had health tips on the back of them. We have a "Thank You" statue that has been provided to the essential workers and will be moved throughout the town.

We will be using the "Code Red System" that Allendale County had to notify the citizens of things happening in the Town.

The Palmetto Palace will be doing COVID-19 testing on Monday, August 17, 2020 on Flat Street, in front of the Allendale Community Center. They have been able to service close to 400 people.

Looking to partnering with Southern Carolina Alliance to do some revalidation throughout the Town. Also working with them on the Rebranding of Allendale County. The design for Allendale County will be finalized on September 16th.
