# **COMMITTEE REPORTS**

<u>Police Departments</u> – Chief Sullivan stated that they have increased patrol as much as they can. They also have had more check points as possible. Chief Sullivan also introduced our new Officer Marcus Broadnax that has joined the department. Mr. Youmans also stated that Officer Broadnax qualified as an expert on his firing requirements.

Chief Sullivan also introduced the Community Relations Officer/Recruiter as Officer D. Badger. She will be keeping the Police Department Web Page updated as well as, communicating with the citizens.
