COMMITTEE REPORTS

<u>Finance</u> - Mr. Youmans gave the Finance Report, for the current fiscal year. Mr. Youmans stated that as of March we have exhausted 67% of our budget for fiscal year 2020.

<u>Police Departments</u> – Chief Sullivan reported that he has met with the Cooter Fest committee, and the department is getting prepared for that. Officer Badger will be going for her final entrance exam, before she goes to the academy. Also the department has been able to increase the patrol in the town area. Also our fines for this quarter has went up \$1600.00.

<u>Personnel</u>

Per Council Lady Harney, 2 officers are needed for the police department. Per Mr. Youmans, the mechanics positions is still on hold. Also for the upcoming year's budget, Mr. Youmans and the Finance Director will make a recommendation for a salary and try to put it in the budget for next year.

Water and Sewer Department

Alan Stanley, Public Works Supervisor informed Council that majority of the month has been spent on the sewer system with the amount of the rain that has come in. Per Mr. Youmans, we have discovered that one our pump stations had a failing pump, in which that pump has since been replaced. This should help in the area of Allen Street. Mr. Youmans also told the citizens, if they have a sewer problem or know someone that has one, please call the Town Hall, so that we can send someone out there to take care of the problem.

Sanitation

Alan Stanley, Public Works Supervisor, stated that Mr. Badger was on call and was out on a call, so he would be giving the report. Per Mr. Stanley, they are still picking bags of leaves and cutting the grass in areas over the town limits.

Community Development

Council Lady Lewis reported that Dollar Tree is almost completed. She met with the Police Department, they will be working with the community closely, so that they will be able to share information, work together and help each other out. Dr. Gibbs she will be partnering with the police department.

The Medical Unit is now at Emma's House. They have been able to serve over a 100 citizens and have more than 100 on the waiting list.
