# **NEW BUSINESS**

## A. Audit Report

The Auditor Forester Mckinney advised that the Town of Allendale's Audit for June 30, 2019 was just completed. Stated that Town has down so much better in the 2019 year and that the Town is on the right track. Councilman Cohen made a motion to approve the Audit of 2019. The motion was seconded by Councilman Grant. Council approved.

# B. Grant Update

# **COMMITTEE REPORTS**

<u>Finance</u> - Councilman Smith stated that he gave a big thank you to Mr. Youmans along with the personal in the office for the great audit that was just completed. Councilman Smith stated that even through the pandemic we were able to pass a budget that will allow us to hire 2 additional police officers and also 2 more police vehicles.

Per Mr. Youmans, as of the end of August we have utilized 17% of the budget. We have open enrollment coming up, we are looking to cut the Town's insurance cost. Mr. Youmans would like to thank the council for their foresight, we were able to establish a General Fund Reserve account.

<u>Police Departments</u> – Captain Ford gave the report stated that they have an officer that is in their 6<sup>th</sup> week at the SCJA and once she passes this week, she will have only 2 more weeks to complete. They are looking to hire 2 more officers at this time, they are in the process of reviewing the resumes and schedule testing. This the 3<sup>rd</sup> session of Court, things are moving slowly. General Session Court has started back and cases are looking good. Early part of September there was a shooting and SLED has been brought in on the investigation.

<u>Personnel/Mechanics</u> – Mr. Youmans gave the report stating that applications for the police department are being looked over.

Mechanics – Per Mr. Youmans stated at this point in our current budget we do not have the funds to hire anyone for this position. But will be at the first of the year, the town will revisit this.

<u>Water and Sewer Department</u> - Alan Stanley, Water & Sewer Superintendent, stated that they were given 60 days to complete all leaks and so far have fixed and repaired 31 leaks. We have 3 leaks left that are from the original list and have 8 or 9 new leaks that are on the list. The department is still working on reading of the meters.

<u>Sanitation</u> – Lonzado Badger, stated that they are cutting the grass throughout the town and still picking up limbs. Also stated that the tree size is getting larger. Mr. Badger stated that the dumping of furniture has decreased lately.

<u>Community Development</u> – Council Lady Lewis, stated that the Palmetto Palace will return Saturday, Sept. 19 on Flat Street in front of the Community Center from 10am – 2 pm.

Mr. Dublin, has given permission to paint a mural on the side of his building, it will be a display of Kite Birds. This should start in about a week or so.

The ARTS Team will resume their Dear Allendale project. They will be interviewing people to get their opinion on what they would like to see in Allendale and what they think of Allendale.

Mr. & Mrs. Harltley will be hosting a "Coffee Connection" at Emma's house. This event will be for the Police Department, Sheriff Department and the National Guard. The date will be announce at a later time.

In the process of making a TV presentation that will be representing the Town of Allendale. This will air on ETV, should be out around the first of the year.

Working on a project called Navigating 2020 and more information will be provided later.
